## **6. Types of Membership:**

### **Student Membership: -**

1. Open to all persons over 12 years of age until 18 years of age except those in full time education who may continue to pay Student subscriptions until 25 years of age or complete their education, whichever is the soonest.
2. Student Members are not entitled to vote.
3. Student Members are not entitled to be nominated and elected to a Committee, save that Student Members may be co-opted onto a Committee in accordance with Rule 11.
4. Student Members under the age of 18 years must be accompanied by a parent or guardian when the student attends the Club or Club events.
5. Parents or guardians of Student Members under the age of 18 years are not required but are encouraged to join the Club.
6. Parents or guardians who become Associate members will not be bound by section 5 of the Associate members requirements whilst undertaking their guardian duties, the restriction will only apply if they attend the club in their own right.
